



If you want to supplement your pre-existing credentials with skills and experience in multiple subject areas, you can choose to complete two different one-year post-degree programs in sequence, for a combined study period of two years.

While a one-year diploma program on its own will currently qualify you to apply for a one-year Post-Graduate Work Permit (PGWP), completion of two different one-year programs qualifies you to apply for a PGWP of up to three years, the same as if you had completed a two-year program. 
